

# Homegrown SportsCentre Membership Rules and Guidelines

membership with Homegrown SportsCentre.

**Preamble:** These Membership Rules and Guidelines (hereinafter referred to as "Rules") outline the conduct, obligations, and responsibilities of members ("Members") of Homegrown SportsCentre (hereinafter referred to as "Facility"). These Rules are distinct from and supplementary to the "Terms and Conditions of Membership" document (hereinafter referred to as "Terms"), which forms the contractual agreement between Homegrown SportsCentre and its Members.

## 1. Applicability:

These Rules shall apply to all Members of the Facility, including its staff, members, and any guests introduced by Members.

## 2. Objectives:

The Rules are established with the following objectives:

- a) Ensuring the safety and security of all individuals within the Facility.
- b) Maintaining and upholding the standards and reputation of the Facility.
- c) Facilitating an enjoyable and harmonious experience for all Members.

## 3. Compliance and Consequences:

- a) Failure to adhere to these Rules may result in appropriate action by Facility management, including but not limited to:
  - Removal from the Facility premises.
  - Denial of access to the Facility.
  - Termination of Membership, as per the Terms.
- b) All actions taken in response to non-compliance shall be at the sole discretion of Facility management.

## 4. Membership:

- a) Members must abide by the following provisions:
  - Upon each entry to the Facility, Members shall use their designated Access Tags for verification.
  - Membership and Access Tags are strictly non-transferable.
  - Access to the Facility shall be denied if Membership Dues are not current or if Membership is frozen, suspended, or terminated.
  - Termination of Membership, as per the Terms, may affect eligibility for future

## 5. Order of Priority for Court and Shooting Machine Hire:

- a) Members with Bookings: Members who have made advance bookings for basketball court or shooting machine usage will have the highest priority. To reserve a slot, members must incur a \$5 booking fee, ensuring their access to the facility at the specified time.
- b) Casuals (Within Allocated Times): Casual users may access the basketball court or shooting machine within the allocated time slots when they are available and not booked by members. Casuals should book their slots via the PlayPoint online portal and check the schedule for open slots.
- c) Members without Bookings: Members who have not made advance bookings may use the basketball court or shooting machine when it is available and not reserved by members or occupied by casual users. Members without bookings should respect the prior reservations of other members.

These rules help maintain a fair and organized system for accessing basketball court and shooting machine facilities, ensuring that members and casual users can enjoy these amenities efficiently.

## 6. Bringing a Guest:

- a) At the discretion of Facility management, Members may introduce guests to the Facility upon payment of the Casual Entry Fee.
- b) Guests are bound by these Rules and are required to complete the Casual Entry Form upon entry.
- c) Members are responsible for the behaviour of their guests, ensuring their compliance with these Rules.
- d) Access to the Facility as a guest is not permitted when a Member's Membership is frozen.

## 7. General Facility Use:

- d) Members shall adhere to posted opening, closing, and staffed hours.
- e) Members shall use wet areas within the Facility at their own risk.
- f) Compliance with reasonable directions from Facility staff is mandatory.
- g) Alcohol and illegal drugs are strictly prohibited within and around the Facility.

- h) Carers accompanying Members shall not engage in Facility use unless they are also Members.
- i) Members shall not use the Facility under the influence of substances impairing judgment.
- j) Smoking is strictly prohibited inside the Facility or near its entrances.
- k) Photography and video recording within the Facility shall respect the privacy and consent of other members.

**8. The Courts and Equipment:**

- a) Equipment shall be used only for its intended purpose and in accordance with provided instructions.
- b) Members shall use clean towels on equipment, including exercise mats.
- c) After use, equipment shall be properly stored.
- d) No food or bags are allowed on the courts.
- e) Glass bottles are not permitted on the courts.
- f) Members shall return balls, ball racks, and equipment to their designated locations.
- g) Members shall sanitize their hands upon entry.

**9. Classes:**

- a) Members attending classes shall arrive punctually.
- b) Class attendance may be subject to limitations as determined by Facility management.
- c) Members shall comply with instructions provided by Coaches and Facility staff.

**10. Attire:**

- a) Members shall wear suitable exercise attire, including enclosed sports shoes, always while in the Facility.
- b) If unsure of appropriate attire, Members may seek guidance from Facility staff.
- c) Facility management reserves the right to request Members to leave the Facility for inappropriate attire.

**11. Storing Belongings:**

- a) Allocated spaces are provided for Members to store their belongings during Facility use. However, the Facility does not guarantee the safety of stored items.
- b) The Facility shall not accept responsibility for any loss or damage to Members' belongings. Unclaimed items may be removed, donated, or disposed of.

**12. Parking:**

- a) Parking within the Facility premises or its surroundings is at the vehicle owner's risk. The

Facility bears no responsibility for vehicle damage or theft.

**13. Coaching:**

- a) Private coaching within the Facility premises is exclusively provided by Homegrown Basketball Academy Coaches. External coaches are not permitted, and Members shall not engage in coaching others within the Facility.

**14. Safety:**

- a) Members shall refrain from obstructing or tampering with fire doors or fire exits, unless directed by Facility staff.
- b) Health and safety notices displayed within the Facility shall be adhered to.
- c) In the event of injury or harm, Members shall notify Facility staff before leaving the Facility, through appropriate channels.

**15. Photography and Media:**

- a) The Facility reserves the right to capture photographs, images, and videos of the Facility and its members for commercial purposes without compensation.
- b) CCTV surveillance is in place for incident monitoring within the Facility.

**16. Pricing and Membership Approval:**

- b) Pricing at the Facility may be subject to change, with prior notification to Members.
- c) Membership approval is entirely at the discretion of Facility management.

**17. Respect:**

- a) Members shall treat fellow members, guests, and Facility staff with respect, ensuring that their conduct does not disturb or impair others' experiences within the Facility.

These Membership Rules and Guidelines shall serve as an integral part of the broader contractual arrangement between Homegrown SportsCentre and its Members, governed by the "Terms and Conditions of Membership." Failure to comply with these Rules may result in the imposition of penalties and consequences in accordance with the Terms.
